The Vendor is a company established in the PRC with limited liability and is owned as to 52.9865% by Mr. Zou Xing Jun\* (鄒興軍), 19.8876% by Shenzhen Tianzhihang Technology Co., Ltd.\* (深圳天之航科技有限公司), 16.5050% by Mr. Mao Rui\* (毛銳) and 6.6381% by Shenzhen Hongfeng e-commerce Co., Ltd.\* (深圳市宏豐電子商務有限公司), and 3.9828% by Mr. Xin Jiandong\* (辛建東), respectively as at the date of this announcement.

Shenzhen Tianzhihang Technology Co., Ltd.\* (深圳天之航科技有限公司) is a company established in the PRC with limited liability and is owned as to 36.7156% by Ms. Yang Dan\* (楊丹), 14.4192% by Mr. Li Yi Da\* (李宜達), 13.3511% by Ms. Yu Jie\* (余捷), 12.1495% by Mr. Zhu Wei Jian\* (朱煒健), 10.0134% by Ms. Li Jing\* (李靜), 6.6756% by Ms. Zhang Qin\* (張琴), 6.6756% by Mr. Shu Yong Yong\* (束永勇) as at the date of this announcement. Shenzhen Hongfeng e-commerce Co., Ltd.\* (深圳市宏豐電子商務有限公司) is a company established in the PRC with limited liability and is wholly owned by Mr. Wang Ze Feng\* (王澤鋒) as at the date of this announcement.

Mr. Zou Xing Jun\* (鄒興軍), aged 50, is currently an executive director and the general manager of the Vendor and has over 20 years' experience in the air transportation services industry in the PRC, and possesses the IATA Training Certificate issued by the International Air Transport Association; also, he is one of the founders of the Target Company, currently the chairman and general manager of the Target Company, and was formerly the vice president of the Aviation Industry Research Institute of China High-tech Industry Innovation Committee (中國高科技產業創新委員會航空產業研究院) and a director of China West Air Co., Ltd.\* (中國西部航空有限責任公司). Mr. Mao Rui\* (毛銳), aged 57, is currently the supervisor of the Vendor and has over 30 years' experience in the aviation maintenance and support industry in the PRC; also, he is currently a director of the Target Company and a director of Chongqing Airport Aircraft Maintenance Co., Ltd.\* (重慶空港飛機維修有限公司).

To the best knowledge, information and belief of the Directors after making reasonable enquiries, the Vendor (including its ultimate beneficial owners) is a third party independent of the Company and its connected persons in accordance with the GEM Listing Rules.
